

Penn East FCU Scholarship Application Packet

Who is eligible?

A student is eligible to apply if he/she or a parent/guardian is a member of Penn East FCU. If the student is not a member and is eligible for membership, he/she may join Penn East FCU, and become eligible to apply. Please note that all accounts must be <u>active</u> and in good standing (checking, ATM, savings, etc.) with no delinquent or charged off loans.

Children of Penn East FCU Officials or employees are not eligible.

Applicant must be a graduating high school senior who will enroll in a full-time undergraduate program during the 2024-2025 school year at an accredited two or four year college/university, or a vocational/technical school in the United States.

How are recipients selected?

Penn East FCU Scholarships will be awarded to applicants who demonstrate:

- Academic Excellence
- Citizenship
- Community and School Involvement

Recipients must also be a member of the credit union or the child of a credit union member.

Applications will be considered on an anonymous basis. Award recipients will be selected by the Board of Directors.

How much are the awards?

Penn East FCU will award three one-year scholarships each in the amount of \$2,500.00.

Awards are made payable to the recipient's school and may be applied to any component of the school's comprehensive fee.

How can a student apply?

Submit this completed application, high school transcript and three letters of recommendation to Penn East FCU to be entered into the Scholarship Program.

The application and all requested information must be received by **Wednesday, February 5, 2025**. Mail all information to:
